1 NEIGHBOR DISPUTE

On the date and time indicated I met with Wayne and Terry Adams at the police station. As I was approaching the station Wayne ran up to my cruiser and began shouting and waving his arms in a tumultuous manner. I observed children and adults on the playground to stop and look in our direction. Wayne began yelling and ordering me to arrest Doug Cormier for threatening his wife and child. I advised Wayne that if he did not calm himself and stop shouting at me that he was going to be arrested for disorderly conduct. At this time Terry and Wayne's daughter approached. Terry began to calm Wayne down. Wayne eventually left the area to go and purchase cigarettes.

Upon Wayne's departure Terry explained that she had let the family dog outside to use the bathroom, That the dog ran to Doug's house, That she called the dog back and told Doug to stop calling the dog, That Doug kept calling the dog and gave the dog a bone, That Doug yelled that he was going to get Wayne (in reference to an open court case between Doug and Wayne). Terry eventually went into the home and woke Wayne to call the dog and Wayne and Doug shouted at one another. It is alleged that Doug called Wayne vulgar names. Terry explained that she felt this was intimidation and needed to be addressed. I explained that the actions described to me did not constitute a crime and informed her that I would speak with Doug and ask him to stop as well as write a report. Terry was also concerned that Doug makes faces at her and her family when he drives by the house. I again explained that calling people names and making faces is not a crime.

At this time I responded to Doug's home and found that there was nobody home. A voice mail was left on Doug's phone asking him to call me at the station when he returned.
