Dear Mr. Adams:

You recently called our office to express concerns that contaminated soil has been used as fill on several properties in Ashburnham, including your own.

As I understand it, you had previously expressed concerns about this subject in 2006 to Paul Malloy, who was then the Chief of the Environmental Crimes Strike Force in this office, and Mr. Malloy had sent you the enclosed letter in response.

According to our records, you called again in November 2007, and have also called a number of times since the end of June 2008. On July 8, 2008, you, your wife and I spoke for over an hour, during which we discussed the fact that you also had a 6-day trial before Judge Lu. On Friday, July 18, 2008, you called a number of different people in the Attorney General's Office and indicated that you were going to file a federal lawsuit.

Given the substantial responsibilities of this office, we have numerous investigations pending, and must use discretion in determining the order of priority of the matters we investigate. I'm sorry that this office cannot be of further assistance.


The Attorney General's Office has reviewed your inquiry to the Criminal Bureau for the purpose of deciding whether to assign your complaint within the Criminal Bureau to initiate a full criminal investigation or prosecution.

The Criminal Bureau of the Attorney General's Office receives inquiries and complaints of criminal conduct on a daily basis from citizens, police departments and other governmental agencies. Every such inquiry and complaint is reviewed to determine whether it is appropriately characterized as criminal, rather than civil in nature; whether it is more appropriately handled by another agency; and whether it falls within the scope of matters generally investigated and prosecuted by the Criminal Bureau. This type of review is necessary because the volume of complaints and inquiries we receive, and limitations on our resources, preclude us from fully investigating and prosecuting all allegations of criminal conduct that are brought to our attention. As you know, two police officers have already expended a considerable amount of time reviewing documents, meeting with you at your home, and in telephone conversations.

Please be advised that the Criminal Bureau is not going to further investigate your complaint at this time. However, for the reasons stated above, this decision should not be construed as a comment on the lawfulness or appropriateness of the conduct about which you complained.

I am sorry that this office cannot be of further assistance to you.
