
On 06-11-07 at approximately 8:45 AM I Sgt. Todd C. Parsons was assigned uniform cruiser patrol for The Town of Ashburnham.

At this time I had occasion to take a complaint from Lynann Lipke of The Water/Sewer department. Lynann informed me that a check of the water curb stop at 57 Fitchburg Rd., The Adams residence revealed that the the curb stop had been vandalized and the lock was cut off enabling The Adams' to turn the water back on.

On 06-05-07 (see attached report 07-196-OF) The Water/Sewer department turned off the water at The Adams' property because there had been no meter installed and the water line installation had not been inspected by The Water/Sewer department. A lock was placed on the curb stop so that the water could not be turned back on until the proper meter was installed and the line inspected by the water department. Lynann stated that on June 7, 2006 Wayne Adams called and informed her that if the water was not turned back on by the end of the day he would take whatever means necessary to turn it back on himself. My report on June 5, 2007 also describes Wayne's threat to turn the water back on. I informed Lynann that I would need a written statement from her and the employee who discovered the damage to the curb stop. Rob Carolis of the water department also supplied me with a written statement describing his observations.

I contacted the assessors office and learned that both Terri and Wayne Adam's were listed on the deed at 57 Fitchburg Rd. charges are being sought for Larceny under \$250.00 (theft of services-to with water) against both Terri and Wayne under Joint Venture.

On Thursday, June 7, 2007, at approximately 1:30 pm, Mr. Adams called the DPW Office requesting to speak to the Department Head. I informed him that Mr. Ouellette was out of the office for a meeting and that I could take his phone number and leave a message for him if he came back into the office at the end of the day otherwise he would not be back in the office until Wednesday, June 13, 2007. Mr. Adams then stated that if he did not hear back from someone that he would turn his water back on himself. He then began stating Mass General Laws and the DPW has violated the laws. I stated that if he tampered with the water curb stop that he would be violating a federal law by tampering with a public utility. He started to become very loud and more irate and I stated that I would not get into this with him and that I would leave the message for the DPW Director. He then started to bad mouth other Town Departments and the way things are run in this Town. I again informed him that I would not get into this with him and he then hung up on me. I then notified Don Ouellette, DPW Director by cell phone and informed both Mark Petersen and Robert Carolis of


